C.H.P.O.A. Status:

Kudos to both Russell Day and Joe Gallagher for plowing the roads in such a timely fashion. Joe has even taken it upon himself to plowing Detour Road from the "Barn House" to our gates. It seems the county relegates this section of Detour Road far down the list of plowing priorities. Thanks again, Joe.

Unfortunately, the community road surfaces have repeatedly turned to ice due to melting snow. Many thanks to Russell Day, Marshall Dyer and Pearl (who the devil is Pear?) for tossing gravel on the icy roads so that all could pass. Gravel has been delivered to the main gate for all to use to spread on the roads when icy. We appreciate all the volunteer

help we can get – including pick-ups! Please help out.

- We have received a letter from a local settlement attorney who feels that their client (a recent purchaser of property in the community) is not responsible for unpaid dues from the seller. A partial copy of our covenants was forwarded to said attorney with specific emphasis to the section of our covenants that states that the grantee (buyer) and successor in title (also the buyer) is responsible for unpaid assessments. Developing. We will keep you informed.
- Roads were repaired this past Fall and looked pretty good at the time. Costs were slightly higher than originally planned due to additional damages caused by Hurricane Isabel after receipt of estimate.
- Disabled association plow truck, extra parts truck and all other remnants of this 2001 Board of Trustees purchase are now a distant memory. They have been sold for \$200 and removed from the community.
- Association signs were vandalized at Detour Road/Trevor Dr/North Trevor Drive intersection. Tom Thompson reinstalled one of the signs and will make remaining repairs this Spring.

From the Co-Chair:

Winter - Beauty or Beast

Winter for some folks may bring the beauty of freshly fallen snow. For others however, the lack of foliage reveals more than most would want to see.

Over the years the board has consistently requested that homeowners follow the rules as stated in the covenants regarding the accumulation of trash, litter, junked and dismantled machinery or scrap materials. All abandoned vehicles are strictly prohibited by

our covenants as well as trailers for more than four months.

There are also Morgan County and state ordinances regarding the accumulation of salvage scrap as well as state regulations regarding unlicensed vehicles per location.

Our covenants are extremely explicit on the requirements regarding the screening of yard equipment, trash receptacles, fuel tanks, etc. Let's work together to be good neighbors and move promptly to clean up our lots.

We plan to fully address this issue at this year's annual meeting and would appreciate your input.

Road Report:

I hope you had an opportunity to drive through the community after the roads were repaired. It was the best I have seen since I've owned property here. They're not perfect, but they turned out really well. We still have a ways to go, and I expect the melting snow and water drain-off will take its toll this Winter/Spring. We expect to address the road issue again before Summer. Depending on projected costs, and our ability to collect delinquent dues, our goal is to partially gravel all of the roads in the subdivision to keep down dust.

But we need your help: We need for you to drive <u>extra slow</u> on our roads. Speeding will scatter the material (dust) and the result will be accelerated future erosion. If you can see dust in your rearview mirror you are driving too fast. Please slow down. This goes for 4-wheelers, too. If you see someone speeding please tell them to SLOW DOWN.

Culverts: If you have not already installed a culvert under your driveway you must install one <u>immediately</u>. If your property is ditched up by the road (generally not ditched if you are on the low side of your road), and you do not have

a culvert installed you are creating a dam in the flow of water. The result is that the water is diverted back onto the road where erosion takes over. For over twenty (20) years our covenants have required a culvert to be installed by each owner where necessary.

Either you can install your own culvert or our contractor will install it for you. The following lots need 12" culverts installed this Spring with their projected costs:

Main Gate Entrance – 40' plus coupler totaling \$440 (association expense) Trevor Road near gate entrance – 20' totaling \$215 (association expense)

> B9 – 20' totaling \$215 C3 – 20' totaling \$215 C19 – 20' totaling \$215 D14 – two 20' totaling \$430 D19 – 40' plus coupler totaling

\$440 B5 – 20' totaling \$215

Our contractor will be instructed, at property owner's expense per our covenants, to dig out any driveways that are damming up our ditches because they do not have culverts. If you have any questions please call me, Russell Day, at 304-258-1732

Where we stand:

Effective February 14, 2004 we had \$9,638.63 in our checking accounts. Account receivables total \$3,183.73 for 2002-03-04 combined. Expenditures since September 30, 2003 are the following:

S & S Excavating \$4,295 for road grading/repairs; H.B. Mellott \$1,681.11 for stone; Bank fees \$62.00; Joe Gallagher \$400.00 for plowing; Russell Day \$332.50 for plowing & road repairs; Post office \$46.43 for stamps.

Secretarial Report:


There are a lot of interesting things to see and do this time of year in greater Berkeley Springs:

Next C.H.P.O.A. Annual Meeting:


