In order to quality for participation in the 2001 West Virginia Cooperative State-County Land Owner CSL Suppression Program as we have in the past, we needed to have an egg mass count of 250 per acre.

Our count came in at 5,320 per acre. We were advised of the potential for severe defoliation. Therefore, the Board elected to authorize our application for aerial spraying.

This \$8.00 per acre assessment notice you received, in addition to your dues notification, is to pay for this spraying. It is mandatory and due immediately. Failure to pay WILL result in liens being placed on delinquent properties.
